Exhibitors will be selected by a jury. The jury will only accept artwork work that is hand-crafted by the exhibiting artist. No mass-produced items, please

DECAF will provide one 10' X 10' booth for the two Youth applicants to share during the weekend. We will put you in contact with the other Youth Vendor and it will be up to you both to coordinate how you would like to set up your shared space.

Tents, tables and chairs will not be provided and are the responsibility of exhibitors to organize in advance. Exhibitors will not be allowed to take over picnic tables or park benches.

Booth location is determined at the discretion of the fair's organizers and will be given to you upon acceptance.

The event will take place rain or shine. Exhibitors are responsible for all contents of their individual booths. Fair organizers accept no responsibility for damage to property of exhibitors as a result of, but not limited to, rain, excessive sunlight/heat, hail, lightning/fire, vandalism or theft.

You may have ONE parent or guardian assist you in your booth if required.

As dictated by city of Toronto regulations, no staking of the ground is possible. In lieu of staking, please use weights to ground your tents (for example, concrete blocks or sandbags).

Unfortunately, electricity is not available for exhibitors at this event.

Participants will be provided with load-in and load-out and parking instructions upon acceptance to the show.

The images you provide in your application may be used in publicity, marketing or advertising materials pertaining to the Danforth East Arts Fair.

You are committing to show both days of the fair. Your booth will be set up by 10am and you will not begin to dismantle your booth until 5pm on each day.

Exhibitors are responsible for removing all items brought to the park and all waste produced as a byproduct of their participation in the show.

The exhibitor undertakes and agrees with the Danforth East Arts Fair that he or she exhibits entirely at his or her own risk and shall be liable for any and all loss whatsoever, caused by the exhibitor, his or her servants or agents or the goods, exhibits or other property belonging to the exhibitor or for which he or she is responsible. Exhibitors are strongly urged to cover themselves against the risk of loss or damage or liability however caused.

The exhibitor undertakes and agrees with the Danforth East Arts Fair to indemnify and save harmless from any and all claims rising out of the exhibitor's use of the facilities and to indemnify and save harmless from the Danforth East Arts Fair any claims and liabilities for any loss, damage theft or destruction whatsoever caused to any goods or any property belonging to the exhibitor, or for which the exhibitor is responsible, beyond the fee paid to participate in the show in the event of cancellation for any reason.
