# RULES AND REGULATIONS:

Page One of Two

The deadline for applications is June 01,2019, sent by email to:  
deca.arts@gmail.com.

The Exhibitor must be a student, secondary or post-secondary, full or part time, to be eligible for the Emerging Artist Booth.

Exhibitors are selected by a jury. The jury accepts only artwork that is hand-crafted by the exhibiting artist. No mass-produced items, please

DECAF provides the opportunity for Exhibitors to showcase and sell their work; Exhibitors agree to stock sufficient items and to be prepared to sell them.

DECAF provides a 10' x 10' tent as a booth space for one or two Emerging Artist Exhibitors. When Exhibitors share a booth space, each Exhibitor agrees to DECAF sharing his or her contact information with the other Exhibitor. Thereafter, the Exhibitors are responsible to coordinate the booth setup with each other.

Exhibitors are responsible to provide any tables, chairs, and display materials required. Exhibitors may not use the park's picnic tables or benches. No staking of the ground is permitted, as per City of Toronto regulations.

Booth location is determined at the discretion of the fair's organizers and will be given to you upon acceptance.

The event takes place rain or shine. Exhibitors are responsible for all contents of their individual booths. Fair organizers accept no responsibility for damage to property of exhibitors as a result of, but not limited to, rain, excessive sunlight/heat, hail, lightning/fire, vandalism or theft.

You may have ONE parent or guardian assist you in your booth if required.

Unfortunately, electricity is not available for exhibitors at this event.

Exhibitors are provided with load-in and load-out and parking instructions upon acceptance to the show.

The images you provide in your application may be used in publicity, marketing or advertising materials pertaining to the Danforth East Arts Fair.

You commit to show both days of the fair; booth setup to be completed by 10am, to stay in place until 5pm each day of the fair.

## RULES AND REGULATIONS:

Page Two of Two

Exhibitors are responsible for removing all items they bring to the park and all waste produced as a byproduct of their participation in the show.

The exhibitor undertakes and agrees with the Danforth East Arts Fair that he or she exhibits entirely at his or her own risk and shall be liable for any and all loss whatsoever, caused by the exhibitor, his or her servants or agents or the goods, exhibits or other property belonging to the exhibitor or for which he or she is responsible. Exhibitors are strongly urged to cover themselves against the risk of loss or damage or liability however caused.

The exhibitor undertakes and agrees with the Danforth East Arts Fair to indemnify and save harmless from any and all claims rising out of the exhibitor's use of the facilities and to indemnify and save harmless from the Danforth East Arts Fair any claims and liabilities for any loss, damage theft or destruction whatsoever caused to any goods or any property belonging to the exhibitor, or for which the exhibitor is responsible, beyond the fee paid to participate in the show in the event of cancellation for any reason.
